What We Do

Voices of Winged Warriors fights on behalf of our loved ones lost to sickle cell disease. VoWW raises the voices of caregivers and centers the needs of those who seek healing and individuals living with SCD. We are dedicated to eradicating systemic bias that supports inequitable treatment and care of individuals with sickle cell disease. We collaborate with medical and community leaders to promote best practices in care, advocate for proactive public health practices, and clear pathways to access. We empower the patient community and its allies through credible education and information, and data gathering and dissemination.









Leadership

Voices of Winged Warriors was founded by Stefanie Worth, mother and caregiver of Thomas Ryan White, who passed away in September 2023 at the age of 26 due to complications of sickle cell disease. Her promise – vow – to Thomas is to continue to fight for other individuals with sickle cell in his honor. We fight to keep warriors alive.

The Founding Board will focus on creating VoWW's programming, developing its first strategic plan, and building infrastructure and a financial foundation that ensure future stability. The organization's Board will be augmented by an Advisory Council to provide additional expertise.

Pillars

- 1) Emergency Care: VoWW is the catalyst behind the Sickle Cell STAT emergency department initiative. STAT supports the work of the American College of Emergency Physicians (ACEP) and the American Society of Hematology (ASH) to help save lives. Through STAT, we also use online surveys to gather patient feedback on emergency treatment and maintenance care.
- 2) Knowledge, Equity & Accountability: In addition to supporting the work of ACEP and ASH, VoWW aligns its efforts with the standards of the Emergency Nurses Association (ENA), which sets emergency department triage levels. We look forward to collaborating with local chapters of each of these organizations as well as quality improvement groups affiliated with state hospital associations and health departments.
- 3) Speaking Out: VoWW aims to collaborate with advocacy and patient-focused organizations in each state to support existing and needed public health practices. This includes action around policies that encompass insurance regulations, medical guidelines and those impacting socioeconomic determinants such as healthy food, access to medical care, education, safe and affordable housing, transportation, and other barriers.
- 4) Education & Economic Empowerment: VoWW aims to work with national sickle cell organizations, local community-based organizations, related health agencies, through social media forums, and other relevant channels to share its emergency department efforts and information learned through its patient surveys to educate and inform patients, caregivers, and allies. VoWW will provide financial literacy, academic support, and educational tools and resources that help warriors obtain and maintain financial independence.
- 5) Healing & Support: Support for those grieving lost Warriors is woven through each of our action pillars. Our goal is to provide a safe space to gather where we can both mourn and celebrate our loved ones. This may manifest as groups, training, and/or programming focused on healing and ways to move forward.

Position type:

- Volunteer
- Governing with fiscal/fiduciary duties

Term of service:

- Member: Each board member will serve a threeyear term, renewable once.
- Officer: Each officer will serve a two-year term, renewable once.
- Resignation: Board members may resign at any time by email to the Board Chair.
- Dismissal: Board members may be dismissed for failure to meet responsibilities.

Time commitment:

- Members: Approximately 1-2 hours per month during 2024 and 2025. Thereafter, approximately 2-4 hours per month.
- Board officers and committee leads: Approximately 2-3 hours per month during 2024 and 2025. Thereafter, approximately 3-4 hours per month.

Meetings:

The full board will meet quarterly. Standing board committees will meet between board meetings. Ad hoc committees will meet as needed. Founding board members will determine meeting dates and times. Board members will be expected to attend 75 percent of full board meetings. Board members are expected to serve on at least one board committee.

Financial commitment: Each board member is expected to support VoWW as one of their top three charitable causes. Each board member is required to donate a personally meaningful gift to VoWW each year.
